### **Information we collect and how we use it**

We offer some services that do not require you to register for an account or provide any personal information to us, such as general information available on our website. In order to provide our full range of services, we may collect the following types of information:

Information you provide – When you sign up for a SpeakNSocial Account or other SpeakNSocial service or promotion that requires registration, we ask you for personal information (such as your name, email address and an account password). For certain services, such as our online billing program, we also request credit card or other payment account information, which we maintain in encrypted form on secure servers. We may combine the information you submit under your account with information from other SpeakNSocial services or third parties in order to provide you with a better experience and to improve the quality of our services. For certain services, we may give you the opportunity to opt out of combining such information.

\* Cookies – We respect the privacy of your computer system and do not send cookies to your system in order to customize your website experience.

. User communications – When you send email or other communications to SpeakNSocial, we may retain those communications in order to process your inquiries, respond to your requests and improve our services.

\* Affiliated SpeakNSocial Services on other sites – We offer some of our services on or through other web sites. Personal information that you provide to those sites may be sent to SpeakNSocial in order to deliver the service. We process such information under this Privacy Policy. The affiliated sites through which our services are offered may have different privacy practices and we encourage you to read their privacy policies. SpeakNSocial only processes personal information for the purposes described in this Privacy Policy and/or the supplementary privacy notices for specific services. In addition to the above, such purposes include:

\* Providing our services, including the display of customized content and advertising; \* Ensuring the technical functioning of our network; \* Protecting the rights or property of SpeakNSocial or our users; SpeakNSocial processes personal information on our servers in the United States of America.

When you sign up for a particular service that requires registration, we ask you to provide personal information. If we use this information in a manner different than the purpose for which it was collected, then we will ask for your consent prior to such use.

If we propose to use personal information for any purposes other than those described in this Privacy Policy and/or in the specific service privacy notices, we will offer you an effective way to opt out of the use of personal information for those other purposes. We will not collect or use sensitive information for purposes other than those described in this Privacy Policy and/or in the supplementary service privacy notices, unless we have obtained your prior consent.

You can decline to submit personal information to any of our services, in which case SpeakNSocial may not be able to provide those services to you.

### **Information Sharing**

SpeakNSocial only shares personal information within our company for the purpose of providing better services or delivery of the service.  
Information

is not shared with other companies or subsidiary businesses.

If SpeakNSocial becomes involved in a merger, acquisition, or any form of sale of some or all of its assets, we will ensure the confidentiality of any personal information involved in such transactions and provide notice before personal information is transferred and becomes subject to a different privacy policy.
